

### CELEBRATING SUN POWER

The Denver Museum of Nature and Science is tapping into abundant Colorado sunshine for a portion of its power needs, thanks to a roof-mounted solar photovoltaic system. It consists of 465 solar panels split between roofs on the southeast and southwest wings of the Museum.

Photovoltaic cells are made up of special materials called semiconductors. Often that material is silicon. When light strikes the cells, a portion of the energy from the light is absorbed into the semiconductor material. The energy knocks electrons loose, allowing them to flow freely. Electric fields within the cells force those electrons to flow in a certain direction. This flow of electrons is called a current, and by placing metal contacts on the top and bottom of the cells, electricity can be drawn from the current to use in the building.

### SOLAR FAST FACTS:

- The Earth receives more energy from the sun in one hour than the human population uses in an entire year.
- The Museum's system will offset over 135 tons of CO2 a year, which is equivalent to planting 11,500 trees
- The photovoltaic array will generate 134,500 kilowatt hours of electricity a year. That's the equivalent to powering 30 homes.

The photovoltaic array at the Museum was made possible through a collaboration of several community leaders in renewable energy, including Hybrid Energy Group, Partnership for Sustainability, Xcel Energy's Solar\*Rewards program, and Namasté Solar Electric.

### Strategies for a Successful Building Safety Week May 3-9, 2009

Your building department or chapter can use the following ideas to promote Building Safety Week in your jurisdiction or region.

### 1. Distribute Building Safety Week Information

Distribute the information and resources in the Code Council's BSW Campaign Kit in governmental offices, hardware stores, building materials suppliers, schools, banks, libraries, etc. The kits include brochures, children's activity books, posters, a news release, logos, pencils and stickers that are fun for all ages.

### 2. Host A Building Department Open House

Hold an open house and arrange public tours of the department conducted by staff members. Include everything from the permit counter to the plan review section. Prepare handout materials to distribute at the end of each tour. Use newspaper, radio and TV announcements to invite the public; schools' civic clubs' and businesses such as plumbing, heating and air-conditioning companies, lumber yards, hardware stores and electrical contractors; as well as architects; engineers and builders.



### 3. Recruit Speakers

Pick Chapter members or officials from your building or fire department to address professional associations, civic groups, construction technology programs, and architectural and engineering schools. These presentations should explain how building safety helps protect people and property.

### 4. Visit An Elementary School


Contact teachers at your local schools and ask if you can come to the school for a presentation on building safety. Bring along copies of CODiE the Cougar's Activity Book, Junior Building Stickers and BSW pencils (all available in the BSW Kit). The activity book provides a good basis for explaining what the building department does and how it makes homes safer for everyone. There's even a Building Safety Certificate in back of the activity book for students.


