WINDOW SAFETY TIPS

Every year, as spring approaches, we see an increase in a very preventable injury: falls from windows. The most common victims are children and according to the Consumer Products Safety Commission, approximately 12 children die and over 4,000 are injured each year.

Incidents tend to rise during spring when people are ready to open up the house and let in fresh air. Couple this with little kids and you have the potential for a major injury. To protect your loved ones, follow these simple rules:

- The safest rule is to keep your windows shut when kids are around, but we all know that this may not be possible. If you can, only open windows that are out of their reach. Also, set a rule against playing near windows and patio doors. Falling through the glass can be fatal.
- Don't rely on insect screens to prevent a fall. Screens are designed to provide ventilation while keeping insects out; they are not designed to, nor will they prevent a child's fall from a window.
- Keep furniture, or anything that kids can climb, away from windows. Kids can be very creative when they want to see out the window so anything may be a climbing tool.
- Consider purchasing a window safety guard system. These systems are easy to install but can be removed quickly in a fire emergency.
- Plant shrubs and soft edging like wood chips or grass under windows to cushion potential falls. The surface can greatly affect the degree of injury sustained from a fall.
- These simple ideas will keep you and your family safe.


May is Building Safety Month

Building Safety Month (BSM), founded by the ICC, is celebrated by jurisdictions worldwide during the month of May.

Building Safety Month is a public awareness campaign to help individuals, families and businesses understand what it takes to create safe and sustainable structures. The campaign reinforces the need for adoption of modern, model building codes, a strong and efficient system of code enforcement and a well-trained, professional workforce to maintain the system.

The campaign is presented by the ICC and its 57,000 members worldwide along with a diverse partnership of professionals from the building construction, design and safety community. All communities need building codes to protect their citizens from disasters like fires, weather-related events and structural collapse. Model building codes are society's best way of protecting homes, offices, schools, manufacturing facilities, stores and entertainment venues. Code officials work day in and day out to keep the public safe. Building Safety Month is a month-long celebration of all aspects of building safety that helps families, employers and leaders understand and appreciate the best practices that keep the places where we live, work and play, safe.
