Please make plans to attend the May CAPT meeting in Douglas County. Glenn Mathewson will be presenting two informative programs making for a wonderful meeting.





# 2009 International Residential Code

# SECTION R315 CARBON MONOXIDE ALARMS

#### R315.1 Carbon monoxide alarms.

For new construction, an approved carbon monoxide alarm shall be installed outside of each separate sleeping area in the immediate vicinity of the bedrooms in dwelling units within which fuel-fired appliances are installed and in dwelling units that have attached garages.




# R315.2 Where required in existing dwellings.

Where work requiring a permit occurs in existing dwellings that have attached garages or in existing dwellings within which fuel-fired appliances exist, carbon monoxide alarms shall be provided in accordance with Section R315.1.

#### R315.3 Alarm requirements.

Single station carbon monoxide alarms shall be listed as complying with UL 2034 and shall be installed in accordance with this code and the manufacturer's installation instructions.

A carbon monoxide detector or CO detector is a device that detects the presence of the carbon monoxide (CO) gas in order to prevent carbon monoxide poisoning. CO is a colorless and odorless compound produced by incomplete combustion. It is often referred to as the "silent killer" because it is virtually undetectable without using detection technology. Elevated levels of CO can be dangerous to humans depending on the amount present and length of exposure. Smaller concentrations can be harmful over longer periods of time while increasing concentrations require diminishing exposure times to be harmful.

## Tension Headaches —

About 30-80 percent of the adult U.S. population suffers from occasional tension headaches; approximately 3 percent suffer from chronic daily tension headaches. Women are twice as likely to suffer from tension-type headaches as men. There is no single cause for tension headaches. This type of headache is not an inherited trait that runs in families. In some people, tension headaches are caused by tightened muscles in the back of the neck and scalp.

This muscle tension may be caused by:

- O Inadequate rest
- O Poor posture
- O Emotional, mental stress, depression
- O Anxiety
- O Fatigue
- O Hunger
- O Overexertion



Tension headaches are usually triggered by some type of environmental or internal stress. The most common sources of stress include family, social relationships, friends, work and school. Examples of stressors include: having problems at home/difficult family life; having a new child; having no close friends; returning to school or training; preparing for tests or exams; going on a vacation; starting a new job; losing a job; being overweight; being a perfectionist; and not getting enough sleep. Learning valuable coping techniques, employing strategies for stress management, and entrusting your physician with your headache issues can help you find a solution.


